

## **Status Report on the GEF Baltic Sea Regional Project, BSRP**

### **Component 1: The Baltic Sea Large Marine Ecosystem Activities.**

Period: 1 September 2001 – 15 June 2002.

The Bureau has received five earlier reports on the project (June 2000, September 2000, January 2001, May 2001 and September 2001). These reports give information on the background to the project, and on activities up to 1 September 2001.

During the period Jan Thulin has been employed at ICES as Chair/Coordinator for the BSRP on full time except for September to December 2001 when he was working half time, and for April to June 2002 when he was on part-time sick leave. His contract now runs to 31 December 2002.

During the ICES ASC 2001, Jan Thulin had several planning and information meetings with key people in Component 1 activities. This was also the case during the Baltic Science Conference in Stockholm during which a steering group for Ships of Opportunity activities, SOOP, was established. The group is now negotiating with ferry owners to extend the coverage of SOOP activities in the Baltic. Further, he participated in the IOC/IUCN/NOAA Large Marine Ecosystem Consultative Meeting in Paris in January 2002 and in an Invasive species Seminar in Tallinn in May 2002. He made presentations of the BSRP at a series of Marine Institutes around the Baltic and several institutes are now preparing letters of agreement with the project.

Most of the work during the autumn was dedicated to seeking donor funds for the first two-year period of the project. Jan Thulin, Staffan Lund, coordinator for Component 2, and Inesis Kiskis, World Bank, visited possible donor organisations and collaborators. These include DANCEE in Denmark, SIDA in Sweden and the Finnish Academy of Science in Finland. With the same purpose, the General Secretary has sent letters to the Ministries of Environment and Agriculture and Fisheries in Sweden and Finland (attached). As yet, these inquiries have not resulted in any larger cash contribution or commitment, although positive signals have been received from Sweden. The above-mentioned three people have negotiated with representatives from the recipient countries with regard to in-kind contributions.

Letters from the General Secretary seeking financial support from the Swedish National Board of Fisheries resulted in January in a contribution of USD 50 000 and in June in a commitment for the same sum for the rest of the year. In a letter from the US Department of Commerce, December 2001, its Deputy Assistant Secretary informed the World Bank that NOAA confirms its commitment to support Component 1 with an in kind contribution of USD 500 000. The General Secretary and Jan Thulin have negotiated with the US Embassy in Copenhagen for a possible contribution of USD 100 000. The IUCN covered the expenses for Jan Thulin's participation in the BMB conference in Stockholm in October 2001, and the LME meeting in Paris in January 2002. The US Embassy in Copenhagen covered the costs for Jan Thulin's participation in the Invasive Species Seminar in Tallinn in May.

As stated in the earlier report, the GEF/World Bank has agreed that the project should run in three two-year periods during 2002-2007. A major reason for this has been the difficulties in finding donor commitments for longer periods than two years. The Project Implementation Plan has now been amended to fit a two-year programme with a budget for Component 1 of USD 5.6 million. Of this, 2.6 million will be a GEF contribution. HELCOM and the World Bank finalised their contract negotiations in May. The World Bank will make its final decision on the BSRP during July. The official signing of the project contracts will be done during the HELCOM HoD meeting on 27 August 2002. Once this is done the project can start its first implementation period.

During the coming months the coordinator will prepare all ICES sub-contracts with institutes and coordinators for centres and lead laboratories. To support and advise in this work an ICES LME team will be established.

The project has as its objective the improved and sustainable use of all the natural resources of the Baltic Sea, for the wider benefit of society throughout the region. Furthermore, the project is widely acknowledged to be a unique and vital opportunity to address the key issues of the Baltic marine ecosystem in a cohesive and programmed manner. Specifically, it seeks to increase sustainable biological productivity, to improve coastal zone management and to reduce agricultural non-point-source pollution, and thus to (a) provide regional decision-makers (in governments and in regional Commissions) with tools for enhanced policies of sustainable management and (b) improve the social and economic status of the farming, coastal and fishing communities.

The GEF Baltic Sea Regional Project has two main components: Component 1 – Large Marine Ecosystem Activities, and Component 2 – Land and Coastal Management Activities, but both are closely interdependent. ICES will be responsible for Component 1, and it is in that connection that I now write to seek your support for Finland becoming a donor country.

The project adopts an ecosystem-based approach to the subject of resource management, and focuses on land-based, coastal zone and marine activities to improve ecosystem health and productivity, social and economic development, and the provision of ecosystem management tools to enable decision-makers to address transboundary issues within the region. The most important aspects of the project are its linkages between land-based activities, the coastal zone and the whole marine environment.

I am aware that all these issues are high on the list of priorities in Finnish government policy.

The GEF Baltic Sea Regional Project thus seeks to build on, and take further, the Joint Comprehensive Environmental Action Programme (JCP) that was initiated by the Baltic countries in the 1990s. The JCP was further elaborated during the Prime Ministers' meeting at Visby in 1996. The recipient countries of the GEF Baltic Sea Regional Project are Estonia, Latvia, Lithuania, Poland and Russia; all nine Baltic countries are contributing to the project.

I will be glad to organise a return visit by him to Finland (at your convenience) so that he can inform you further about the project, if you consider that it would be helpful to do so.

I am aware that Prime Minister Paavo Lipponen has been informed about the GEF Baltic Sea Regional Project by World Bank President Mr. James D. Wolfensohn, at their meeting on 2 November 2001.

I would ask you to give positive consideration to the case for Finland, as a long-standing and important participant in Baltic marine affairs, to also commit significant funds to Component 1 of the programme through your Ministry.
